

**Regulation 26 of the Town and Country Planning  
(Local Planning) (England) Regulations 2012  
Gedling Borough Council Local Planning Document - Adoption Statement**

Notice is given that Gedling Borough Council formally adopted its Local Planning Document on 18<sup>th</sup> July 2018. The Local Planning Document (Part 2 Local Plan) will work with the Aligned Core Strategy (Part 1 Local Plan) to shape future development in Gedling Borough up to 2028.

An independent inspector appointed by the Secretary of State for Housing, Communities and Local Government considered the Local Planning Document at public examination hearings held between February and December 2017. The Council consulted on proposed Main Modifications and Additional Modifications to the Local Planning Document between 12<sup>th</sup> February and 26<sup>th</sup> March 2018. The Inspector's Report was received by Gedling Borough Council on 26<sup>th</sup> June 2018. The Local Planning Document incorporates the Additional Modifications and all Main Modifications recommended by the Inspector.

**Any person aggrieved by the Local Planning Document may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act (2004). Any challenge must be made on the grounds that either the document has not been prepared within the powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004 and/or that one or more procedural requirements of the Act or associated Regulations have not been complied with. Any such application must be made no later than the end of a period of six weeks, beginning from the date the Local Planning Document was adopted.**

The adopted Local Planning Document and associated documents are now available for public inspection at the following locations. (These documents include the adopted Local Planning Document, Inspector's Report, Adoption Statement, Sustainability Appraisal and its associated Sustainability Appraisal Adoption Statement (which includes further details required under Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004)).
