

SUBMISSION PAPPLEWICK NEIGHBOURHOOD PLAN NEIGHBOURHOOD PLANNING (GENERAL) REGULATIONS 2012 SUBMISSION OF NEIGHBOURHOOD PLAN PROPOSAL REGULATION 16 NOTIFICATION

Papplewick Parish Council has submitted a Neighbourhood Plan proposal under Regulation 15(1) of the Town and Country Planning Neighbourhood Planning (General) Regulations 2012.

The Neighbourhood Plan has been prepared by a Working Group made up of Parish Councillors and local residents and sets out the vision, objectives and policies to ensure that the Parish of Papplewick maintains it uniqueness over the period 2017 to 2028. If the Plan is adopted by means of a parish referendum it will become part of the development plan used for determining planning applications in Papplewick until 2028.

Gedling Borough Council is required to publicise the proposed Neighbourhood Plan. The Submission Neighbourhood Plan (and supporting documents) can be viewed online or inspected at the following locations (during normal opening hours):

Completed questionnaires can be sent to Planning Policy, Gedling Borough Council, Civic Centre, Arnot Hill Park, Arnold, Nottingham NG5 6LU or by e-mail planningpolicy@gedling.gov.uk. The consultation will commence on 19 February 2018 for six weeks until 5pm on Friday 6 April 2018, by which time all representations must be received.

Any representations made may include a request to be notified of Gedling Borough Council's decision to 'make' the Papplewick Neighbourhood Plan, following independent Examination and a parish referendum.

Following the consultation all representations received along with the Submission Papplewick Neighbourhood Plan (and supporting documents) will be forwarded to an independent Examiner who will recommend whether or not the Plan should proceed to parish referendum.
