I refer to my previous email (copy attached) advising that a report regarding the Gedling Access Road (Scheme update , Compulsory Purchase and Side Roads Orders) was to be considered by the County Council's Transport and Highways Committee today.

I can advise the Council's Transport and Highways Committee has today (16th March 2017) approved the report as submitted. Officers are now authorised to prepare and make the necessary Compulsory Purchase and Side Road Orders and use their best endeavours to deliver the Gedling Access Road at the earliest opportunity. The timeline for achieving this is set out in paragraph 71 of the report and I can confirm that this is the timeline that officers are working to, and if achieved, would see construction of the Gedling Access Road commence in Spring 2018 and be completed and open to traffic in Spring 2020.

I trust that you will bring this information to the attention of the Inspector.
