## Examination into the Soundness of the Gedling Borough Council – Local Planning Document, Local Plan Part 2

Further to our letter dated 14<sup>th</sup> October 2016, I am now able to provide you with two of the additional evidence documents that we had advised would become available post submission.

I therefore enclose a CD which includes the following documents:-

- Draft Woodborough Conservation Area Character Appraisal and Management Plan (Nov 2016) – consultation is taking place between 16th November and 16<sup>th</sup> December 2016.
- Gedling Borough Council Playing Pitch Strategy and Action Plan approved at Cabinet on 3<sup>rd</sup> November 2016.
