**SUBMISSION OF NEIGHBOURHOOD PLAN PROPOSAL**  
**REGULATION 16 NOTIFICATION**

Burton Joyce Parish Council has submitted a Neighbourhood Plan proposal under Regulation 15(1) of the Town and Country Planning Neighbourhood Planning (General) Regulations 2012.

The Neighbourhood Plan has been prepared by a Steering Group made up of Parish Councillors and local residents and sets out the vision, objectives and policies to guide the sustainable development of the Parish of Burton Joyce up to 2028. If the Plan is adopted by means of a parish referendum it will become part of the development plan used for determining planning applications in Burton Joyce until 2028.

Gedling Borough Council is required to publicise the Submission Neighbourhood Plan. The Submission Neighbourhood Plan (and supporting documents) can be viewed online or inspected at the following locations (during normal opening hours):

The consultation will commence on Friday 27<sup>th</sup> July 2018 and run **until 5pm on Friday 14<sup>th</sup> September 2018**, by which time all representations must be received.

Any representations made may include a request to be notified of Gedling Borough Council's decision to 'make' the Burton Joyce Neighbourhood Plan, following independent Examination and a parish referendum.

Following the consultation, all representations received along with the Submission Burton Joyce Neighbourhood Plan (and supporting documents) will be forwarded to an independent Examiner who will recommend any amendments and whether or not the Plan should proceed to parish referendum.
